

EL PASEO VALET

MONTHLY PARKING PERMIT AGREEMENT

THIS AGREEMENT IS BETWEEN EL PASEO VALET (EPV) AND THE APPLICANT ONLY.

The Effective Date of this Agreement will be upon signing.

EPV, with this Agreement, will issue a non-transferrable monthly parking permit that may only be used by the person and vehicle(s) listed in the Application. Either Party may terminate this Agreement, without cause, with 30-days written notice to the other Party.

Initial Monthly parking fees shall be paid in advance. Initial payment shall include the first month's fee and a deposit equal to one month's fee. All checks are payable to El Paseo Valet.

Monthly parking fees will be invoiced by the 25th of each month and are payable the 1st day of each month. If payment is not received by the 5th day of the month a late fee of \$25 will be added to the next invoice. Invoiced fees more than 30-days past due will subject the EPV Monthly Parking Permit to termination.

Each Monthly Customer is issued a numbered window sticker that must match the vehicle(s) recorded at the time of signing. Absolutely NO window sticker sharing is allowed. Each Customer must keep their window sticker visible for compliance. Replacement stickers are available at a cost of \$25.00 per incident.

Monthly invoices and fees will be generated according to the schedule of services personally selected by each Customer from the EPV Pricing Table published and maintained at www.elpaseovalet.com. If Customer wishes to change the selection of services they must notify EPV with 30-days prior written notice for invoice modification.

EPV policy requires (1) one spare key per authorized vehicle to be provided by Customer upon receiving the EPV parking sticker. Any temporary exception to this policy will result in a \$2.50 daily penalty fee that will accrue until the policy guideline is satisfied. Failure to comply with this policy after 30-days will subject the EPV Monthly Parking Permit to termination.

EPV does not provide a Security Agreement and assumes no liability for lost/stolen items or criminal activity. EPV assumes no liability for any damage to Customer property when damage is caused by a third-party.

EPV reserves the right to immediately suspend Customer privileges, at its full discretion, based on any occurrence of negligent conduct on the Lot. The maximum speed limit on the Lot is 5 MPH. EPV Valets have full discretion to notify all Customers of policies to observe as well as the correction of any negligent actions.

Incident Reports are available at the EPV Kiosk for Customers to notify EPV of damages PRIOR to leaving the facility on the day suspected damage may have occurred on the Lot. Incident Reports can only be logged by EPV for suspected damage while the vehicle is still on the Lot for inspection. No exceptions.
